The noble Polish family Babinski coat of arms Boycza (Boycza, MAus zel, MAus zele, MAus zelie, Piaseczna, Piasnicza).

Babinski coat of arms Boycza. Volyn 1528. Led around 1825 in Poland the proof of nobility.

Pogorzałkach 1792, married to Maryann Rudzieńska, left the following descendants: Franciszek, b. 1822 Teofil, b. 1824 Eugene, b . 1834 Roman , born. 1835 Wladyslaw, b. 1839 Valery, b. 1.844 Marcella and Apollinaris. II. Tomek ekekasz, b. in Cieszymach (met in Kowarenn from 1696), with his wife Alexandra, had a son, Paweł, who was born. in pastor kach years 1714 ( met in Zawady ) , married to Constanta Grabowska . Jakub , by Rozalia Truskolaskich son Kasper, b. in Kruszewo 1822 (met in Kovarn).

Mitko Ivanovich Babinsky received from Aleksander the Jagiellonian. in 1492 in the district Deniatyn Krzemieniec ( Ptasz. ) his son Semen Mitkowicz , witnessed the sale of Rosołowiec 1523 (archive MMI VII. I.), sold the village to Jan, bishop of Vilnius 1534 (lit. Karst. Dipl.-Ing.). The same Semen, a royal courtier 1548 (ML 50), built in 1544, a wooden castle in ShiTomek ekekir. In 1583 Andrzej was the heir of Babina and Wasil - Olszany village in Lutsk district (Jabł.). Andrzej, made in 1569, the oath of allegiance, after entering Volhynia the crown (archive MMI II. I.). Wasil, Leo and Iwan, sons of Andrzej, met distribution of estates in 1577, Piotr and Elias, sons of Wasil, divided assets in 1624 (Stecki). Marancya von Krasieńskich, widow of Leo Babinski, Sanguszko in 1621 confirm Jan , 1628 a case of Kossakowskimi . Piotr and Jadwiga Parisów, married in 1636, took a promise from the Hoyskich , Rokitna and Masowice . Her son-in-law was Mikołaj Lubieniecki (Woł. IV f 1028 f 192 VB, VI. B. f 314 and 321, VI. D. f 44). Jerzy wrote the Volhynia province on the election of Jan Kazimierz. Adam , armies of Lomza , 1625 , was Antoni , bailiff of Plock , Wojski (officer and guardian of the voivodeships when the voivodeships and castellans were at war) m zawSkrzyński m in 1742 Antoni , son of Franciszek and Teresa Kulwieckich, scribe commune Plock year 1756 (DW 55 f 1756), married Maryann KoziobrFrom zką, wojszczankę zawskrzyńską, had a daughter, Barbara. whose sons : Mikołaj , Bonifatius and Józef presented in the years 1839 to 1848. Paweł, the Lipniku heir in 1768 had sons, Stanislaus and Jacendies. Ignacy and Bartłomiej's sons Stanislaus and Józef , the son of Jacendies , bailiffs presented the Earth Wizna in the years 1840-1843. Matthias , the successor Lipniku in 1787 had a son , Andrzej, after whom the children: Augustine, Ludwik, Adam and Teodor, witnessed the nobility in the years 1839-1843 . Stanisław , owner of Wierzbica 1727 , had a son after which the wife Teofili Kamieńska, sons Tomek ekekasz, Jan and Napoleon, the issue in the years 1840 to 1847, and Felicyan, son of Tomek ekekasz, 1849 Jan, the heir of the Zamiecinie 1699 Son of Piotr, after that the son of Matthias , had a son , Józef , and that Antoni , whose two nieces : Feliks and Józef put in the years 1847 to 1850 . As Szymon , the second is known Józef , sons Jan and Stanislaus, in 1851, presented the Piotr, the heir Zamięcinie 1781, a son of Michał, whose sons : Józef and Damazy , in 1843 , presented the Łukasz , the owner 1778 the son of Wawrzyniec, left Kosemina sons, Franciszek, Jan and Jakub, proved the nobility of the nobility in the years 1841-1847. Mateusz, the fourth son of Franciszek, with his wife, left Christine Wyszyńska with sons Gabryel, Chancellor of the Cathedral of Kyiv, Stanislaus , who died childless , and W (?) father (?) . The latter Bogumiły Siemaszkówny sons, Aleksander, who died childless, Leon, Marshall County Kyiv, died 1839 by Magdalene Niemiryczówny had two sons, Feliks and Franciszek. Feliks, who in 1826, married Anna Ushakov, daughter of Michał, the General of the Russian Army, he left four daughters: Dorotas Freygangiem Wawrzyn Henrykk, Director of the Post Office in Warsaw, Leśniowskim Katarzyna, Wladvslaw Anna Faustvn Rulikowskim, Wasilkowski County Speaker and Anastasius for Waclav Rulikowskim. Franciszek, Marshall County Kyiv, died 1855 married 1-o v. the Henryk and Grocholska from Woronowicy, second time desessarts with Amelia, the first wife left her daughter Isabella, who died a child. , died 1898 with which Leonia Garnyszów was born without sons , Leo . 1868 owner Tłusteńka, married to Aniela Franciszek. b. Skibniewska. in 1871 the owner 1903. with Trybuchowiec , who married in Martha Narkiewiczówna Abazyi JAus kówna, daughter of Jan and Jadwiga Chylińskich , Ludwik, b . 1872 Kociubińcach , owner Kolendzian , an Austrian imperial eunuch lieutenant of hussars and Piotr, b. W (?) father (?) Rudolf 1875 ensign of Przemysl, died 1810, after the widow, Katarzyny Józef Jaworski, one-on v. Komorowska, granted him a monument in Żurawica. Apolonia, daughter of Józef, Swordbearer Sanok , for HR . Komorowski Cypryjanem 1803 (Goł.; Bork, And Me Valve). The same Iwaszko himself Exhibitedanother , he lives Hniewosz Iwaszkowicz in 1497 sold 1522 Wołkoszów prince Ostrogskiemu and appeared 1528 years , the parade ground Volhynia, five horses (Archive Sang.). Noble Pan J. Wolff, due to the fact that Hniewosz had a quarter of Pater's inheritance. Andrzej Sanguszki in Derna, Aus eradach and Moszczenica after Paszku Dochnowiczu that three quarters had a son prince. Andrzej says Iwaszko JeŁowicki, , Hniewosza father, who married daughter Fürst wa Andrzej Sanguszki and Chreptowiczównej, that while there is only one of their daughter, Fürst known. Anna Bohuszowa Korecka, so I assumed that it was the first time for JeŁowicki. This claim is not because Prince Andrzej Sanguszko, still a minor in 1501, married, in 1507 only about Hanna Chreptowiczównę, so his grandson could not IeŁowicki. who already own Hniewosz Wołkoszów Ostrogskiemu 1522 rather probably be the seller that Iwan JeŁowicki, with the daughter of Pasha Dochnowicza was to be married and thus his son after his mother Hniewosz had issued a guarter of the inheritance that Hniewosz JeŁowicki, , was married to the daughter of prince. Andrzej Sanguszki who gave him a quarter of his macierzyzny. Hniewosz 1545 testified according to his will Sanguszkowa (Archive Sang. III and IV). In the years 1533-1538 sued Prince Zasławską, some common people, which Zasławski questioned king Zygmunt, his letter 1538 ordered. In this letter, a landowner named Hniewosz Volhynia (Jun. 20, 30 and 37). Hniewosz , owner of dwelling house and Turykowicz, in district Krzemieniec 1545 (rev. Z Silicon), left four sons : Antoni, Fedora, who died before 1565, Dmitri and Sawa, all living in Volhynia 1557 (M. 90 f. 292) . They met Krzemieniec 1567 department other estates from his father, a village consisting of : Łanowce, Mill ówka, Oryszkowce, Disorder, Płoska, tenement houses, Turykowce, Piratyń, Highlands, Zabłocie, Mirohoszcze, Silence and Nosowice (Group and Zs. Krzemien . in 1568). Daughters Hniewosza: Bohdanna came 1554 Michał Jełowicza Malinski (Kniaź.), Marshal hospAus arskiego 1579 (Zs Luck.) and was the wife of Jerzy Nastazya

Antoni Hniewoszewicz JeŁowicki , , 1566, the judge Krzemieniecki, the owner of the dwelling house in 1583 and seven villages in the district of Krzemieniec and Wojsiecza and Mosary, in the district of Lutsk (Jabł.), to Eudoksya N., who filed a lawsuit against the 1566 year Montolta brought married, a theft from the treated (Op. Luc. 2.040). His second wife was Raina ŁahAus owska 1586 (Zs. Luckie). His three sons: Michał, Mikołaj and Andrzej and daughters Zofia, wife of one-on Wenzel v. Wielhorski, 2- by Stanislaus v. Wilam, Barbara, for Hrehorym Kołmowskim and Katarzyny , one-on v. Khomiakov, second time Hawryłowa Hostska 1584 years ( Woł. IV f 195, f 177 VA and VII A 192 f). Michał, the son of Antoni, sued the Firlejami in 1593 for escaping subjects (Woł. and f 8). Mikołaj , son of Antonius, the defendant in 1590 , together with the successors and guardians remaining property after Antoni , the Ruzyňská , the mother's separation from her department in Wojszycach ( Woł. 1 f 11). Andrzej, the owners Piratyna, Michalkow and Turykowicz. of Mikołaj, Armeen Krzemieniecki; Aleksander, son Piracynie a will in 1647 and died the same year (Group Krzemien . ) . Married EuphroSohn e Pociejówną who registered 2,000 fl. during its majtku 1623 and together with the year 1639 it has received royal agreement to buy Sierkowszczyzny, in the province of Kyiv, in the hands of the Turobojskiego (M. 184 f 44) . Andrzej , son Mikołaj , testified 1633, Scots Krzemieniec entry for life with his wife Regina of Pstrychkoni Pstrokońska, daughter of Stanislaus, who as a widow, testified 15 January 1667 years and died soon after (Group Krzemien.). Their children: Mikołaj Aleksander, Stefan, Katarzyny Iwanov Deniskowa, Maryanna Kryštofovo Morsztyns and Joanna, Scots sue Krzemieniec in 1669 with Katarzyna of Bołbasów Jełowicka. Apart from that he had his son Andrzej Michał Marcin v. Marcy, Wojski (officer and guard of the voivodeships when the voivodes and castellans were at war) ego in 1649 1654 Krzemieniec from councilman not living already 1669 married to Katarzyny said only Bołbasówna Rostocka she just sued o his siblings 1669 (WOL . VII B 101 f and Bracł XV 1439 f). His son Adam, b. Franciszek Adam , the owner of Rostock, sued the whitefish 1673. He was a companion character Marshal in Lubomirski armored and had a total save in Rostoki Radlińskiemu , Dominican owi from PAus kamienia , which is why it was issued between Radlińskim and Żółkiewski 1690 year (Zap. f 55 221 and vol. IX f 1056). Constantine Bożeniec JeŁowicki, , Edler NovgorAus , son of Adam and grandson of Marcy and Katarzyny Bołbasów Rostock, oneon v. Żytyńskiej, in 1717, along with his uncles Marcin, Żytyńskich, Zolkiewski and others, complains about the inheritance of his babka (Bracł. XV 1557 f). His son Józef, against which Samuel manifested in 1721, issued a declaration of nullity on the script (ibid. xv f in 1776). Alexander v. Mikołaj Aleksander , brother Marcin , noble
